### The venue and surrounding area

Situated on the outskirts of the Central Business District, the Cape Town International Convention Centre (CTICC) is close to the vibrant beat of the city's heart. Many of the city's landmarks, shops, buildings and cultural attractions are only a few minutes walk from the CTICC. The nearby V&A Waterfront, with its mesmerizing list of restaurants, boutiques, malls, and creative characters, remains the country's most visited venue. One of the landmarks of Cape Town, namely Table Mountain, offers spectacular views in all directions and gives a birds eye view of the city. The famous Robben Island, whose prison was once home to former South African president Nelson Mandela as well as many other black political freedom fighters, is now a World Heritage Site and provides stunning views across the bay with Table Mountain as its backdrop.

# Congress Theme

The theme of the Congress is Public Policy and Development, and focuses on how the tools and methods of public economics can serve to understand the processes of development, and to help design policies that can accelerate development. A broad range of questions falls under the purview of the general theme, encompassing issues like expenditure, taxation and fiscal balance; poverty and inequality; regulation; implications of globalization; national, regional and global public goods; the role of development assistance; and the political economy of public policy choice. Plenary speakers will be invited to address this range of topics.

While the theme of the congress is public policy and development, contributing papers on any topic within the field of public economics will be considered, as is tradition at IIPF congresses. Submissions are invited by all public finance economists in their respective fields of speciality.
